

2021 Heiskell's Feed Depot Gift Card Sweepstakes

Tucoemas Federal Credit Union ("Sponsor") and this Sweepstakes is in no way endorsed or administered by Visa, Instagram, Twitter or Facebook.

1. ELIGIBILITY: This Sweepstakes is open to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older at the time of entry.

The following persons are not eligible to enter the Sweepstakes:

phone number, and email address no later than 1 P.M. PST on Wednesday, March 31, 2021.

3. ODDS OF WINNING: The actual odds of winning will depend upon the actual number of entries received for this sweepstakes.

4. RANDOM DRAWING: On or about Thursday, April 01, 2021, at 3 P.M., a random drawing will be conducted from among all eligible entries received. There will be one (1) prize "Winner" drawn in total. The winner will be notified as outlined in #7 - "Claiming Prize" (below). Winner need not be present to win.

5. PRIZE: One (1) winner will receive one (1) \$500 Heiskell's Feed Depot gift card. There will be one (1) prize "Winner" drawn in total. The winner will be notified as outlined in #7 - "Claiming Prize" (below). Winner need not be present to win.
